OUR MESSAGE

Every Arizonan deserves the freedom to make our own healthcare choices, not politicians. Without this amendment, extremists will never stop pushing for a total ban. That's why we're working to amend the state constitution and protect our right to make private and personal decisions with our family and provider, free from government interference.

Opposition Lie

The Arizona Abortion Access Act removes all manner of safety regulations and safeguards for girls, women and doctors. Variations of this claim may sound like "The AAA removes safeguards and safety precautions that protect girls and women. It eliminates the need to see a qualified doctor and lets chiropractors and dentists give abortions; it requires providers to perform abortions against their will; it removes clinical safety standards; it is unrestricted and unregulated; it doesn't take girls' and women's health seriously; it damages the doctor-patient relationship and it allows dangerous late-term abortions."

THE TRUTH

The Arizona Abortion Access Act ensures abortion is regulated like any other health care procedure, while also giving Arizonans the freedom to access abortion care without government interference. It doesn't remove any medical safeguards or safety precautions for abortion care or change the requirement that abortion be provided by licensed, qualified medical professionals.

Opposition Lie

The Arizona Abortion Access Act opens the floodgates to call any minor complaint a valid "mental health" issue to allow abortion-on-demand.

THE TRUTH

Not true. The amendment puts healthcare decisions where they belong: with patients, their families, and their health care providers. We have seen politicians in other states use this lie to justify extreme bans and, without this amendment, politicians in Arizona will do the same. There are deeply personal reasons why someone may have an abortion. Arizonans deserve the right to make those decisions free from government interference.

Opposition Lie

Arizona already allows abortion up to 15 weeks. That's a reasonable limit that abortion extremists don't want to admit is adequate and popular.

THE TRUTH

An extreme ban at 15 weeks robs Arizonans of the right to make the decision that is best for us. We know from patient stories here in Arizona and in other states, like Florida, Texas, and Oklahoma, that abortion bans harm pregnant patients and prevent healthcare providers from giving them the care they need. We know from their own statements that anti-abortion politicians in Arizona will keep pushing for more and more extreme bans - unless we stop them with this Constitutional amendment. This measure ensures that a patient's need, not politics, will drive medical decisions in Arizona.

Opposition Lie

The Arizona Abortion Access Act could force Arizona taxpayers to fund abortion, even for non-residents.

THE TRUTH

There is no such language for that in the proposed amendment. This amendment simply lets Arizonans have the freedom to make our own decisions.
